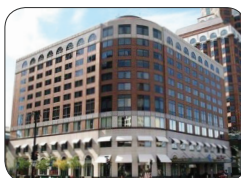

**Paul Brodwin, PhD** is a Professor of Anthropology at the University of Wisconsin-Milwaukee and an Adjunct Professor in the Center for Bioethics and Medical Humanities at the Medical College of Wisconsin.



**Burr Eichelman, MD, PhD** is an Emeritus Professor of Psychiatry at University of Wisconsin-Madison School of Medicine & Public Health, and Supervising Psychiatrist for the Women's Correctional System of Wisconsin's Department of Corrections.



**Michael Koenigs, PhD** is an Associate Professor of Psychiatry at the University of Wisconsin-Madison and Principal Investigator of Koenigs Lab in studying the neurobiology of human emotion, decision-making, and social behavior.



**Douglas Mossman, MD** is Professor of Clinical Psychiatry and Program Director for the Forensic Psychiatry Fellowship at the University of Cincinnati College of Medicine. Hundreds of scientific and legal publications have cited his 1994 article, "Assessing Predictions of Violence: Being Accurate about Accuracy," the first publication to apply receiver operating characteristic analysis to psycholegal problems.
