I will provide recommendations for improving outcomes for emerging adults including how to utilize transition planning for effectively reducing recidivism rates. We will discuss the unique developmental and housing needs of emerging adults as well as the daily living skill sets needed to function independently.

1A	End Stage Renal Disease Care and Treatment	Paula Stelsel, BSN, RN, CNN - <i>Nursing Coordinator, WI DOC, Bureau of Health Services</i> Joseph Narance, RN - <i>Nursing Supervisor – Dialysis, WI DOC, Bureau of Health Services</i> Anita Popp, RN, BSN, NCCHC - <i>Nurse Clinician 4/Peritoneal Dialysis, WI DOC, Bureau of Health Services</i>	This presentation will provide an overview of End Stage Renal Disease. ESRD is highly prevalent in the correctional setting and nationwide. ESRD affects many body systems and requires ongoing medical intervention, oversight, education and collaboration of a multidisciplinary team. This presentation will address the role of the nurse in caring for patients with ESRD, distinguishing between corrections and community settings, and discuss what nurses should know about the care of dialysis patients, both before treatment and after.

<b>1B</b>	<b>Vaping: A New Public Health Safety Concern</b>	<b>Diane Marcyjanik, PhD, RN</b> – <i>Assistant Professor, UW-Eau Claire</i> <b>Lyndsey Strang, RN, BSN</b> - <i>Graduate Research Assistant, UW-Eau Claire</i>	The U.S. Surgeon General reported that the use of electronic cigarettes (e-cigarettes) is on the rise among adolescents and continues to be a public health concern. Adults can influence the conversation on the dangers of e-cigarettes and vaping. Adolescents are extremely susceptible to peer-pressure and pressure from social media, and as a result, they do not always look at warning signs before using products like these. According to the Centers for Disease Control, there is evidence that adolescents who use e-cigarettes are more likely to smoke regular cigarettes in the future. When correctional professionals become knowledgeable about the dangers of vaping, and in turn, educate the public it could help stop this dangerous trend from progressing. This presentation will help start the important and necessary conversation to increase knowledge about e-cigarettes and vaping along with providing helpful resources.

Caldwell, PhD, CCHP-MH</b> - <i>Vice President of Mental Health Services, Advanced Correctional Healthcare, Inc./USA Medical and Psychological Staffing, SC</i>	The suicide rate among incarcerated persons has been on an upward trend for many years with suicide being the most common cause of litigation. For each tragic loss of life, there is an opportunity to learn, implement change, and save lives. This presentation takes a psycholegal approach, describing scenarios involving suicide by incarcerated persons and the ways that delivery of healthcare can be adjusted to prevent such outcomes and reduce the potential for legal action. Although care will be taken to protect the identity of persons involved, real cases will be reviewed and case analyses will be presented.

You will learn about the signs and symptoms of opioid misuse and abuse, and how medication-assisted treatment (MAT) is being implemented in Wisconsin. We will also explain how Wisconsin has used various funding sources and grants to respond to the epidemic.

3A	<b>Go with Your Gut – Comprehensive GI Assessment</b>	<b>Valerie Verbist, FNP – APNP, GI Associates</b>	This presentation will focus on the GI assessment, including common presentations/manifestations of some common GI conditions, both acute and chronic. It will include differential diagnoses for commonly reported GI symptoms, interpretation of some commonly ordered labs (i.e. LFT's, etc.) and red flag GI symptoms that warrant more urgent workup. Some of the conditions/symptoms included will be liver disease, diarrhea, acute abdominal pain, inflammatory bowel disease (Crohn's, UC), and irritable bowel syndrome, along with brief overview of several other conditions.
3B	<b>Building a Multi-Generational Team</b>	<b>Pastor Andrew Gutberlet, BA</b> - Pastor of Discipleship and Equipping, Highland Community Church	This session examines the difficulties many employers face when trying to recruit and retain Millennial and Generation Z workers. These younger generations are motivated in very different ways than past generations. Knowledge of these changes is vital for building successful teams in a multi-generational workplace. Lastly, we will examine outdated approaches to staff recruiting while also offering a helpful course correction.
3C	<b>From Crappy to Happy: A Wellness-Based Approach to Fighting Burnout</b>	<b>Dr. Julia M Persike, PsyD, CSAC</b> - Independent Speaker, Trainer and Consultant	Stress. Cynicism. Hopelessness. Exhaustion. Depression. Anger. The symptoms of compassion fatigue (professional burnout) vary by person and can lead to skewed professional judgement, apathy/indifference, and chronic medical conditions (Mathieu, 2007). Whether experienced by a social worker, nurse, law enforcement officer, or supervisor, burnout is an unavoidable yet fully manageable condition experienced by professional helpers. Tasked with providing care and supervision, professional helpers often unknowingly wear stress and burnout like a badge of honor. This session will explore the historical roots of burnout, secondary trauma, and correctional fatigue. Participants will learn how burnout impacts individuals and entire departments. Participants will also examine practical, wellness-based prevention methods and coping strategies. Lastly, participants will walk away feeling refreshed, empowered, and ready to return to their vital role of professional helper.
