



## Who is WNA?

- WNA is a 111 year old nursing association with membership opened to RN in Wisconsin
- Mission: To be the voice and principal advocate for the nursing profession grounded our core value.
- Structure: The WNA Board of Directors, a corporate body, which serves as the agent of the WNA membership.
- Councils: The Public Policy Council is one of WNA's Councils that addresses policy, legislation and regulation that impact nurses and nursing.

## Who is WNA?

- WNA Public Policy Council
  - Composes of 6 – 10 members who are elected or appointed by the Board.
  - Develop the “WNA Public Policy Agenda (PPA) for the Legislative Biennium. Identifies our priorities and areas of legislation that supports and advances nursing so that patient have access to quality and safe care.
  - Review and decide positions on proposed legislation using the PPA. There are about 2,000 bills introduced in 2020 each health related comprise around 15%. (300 bills)

## WNA Government Affairs Program

- Know the health care agenda of the two legislative parties
- Review legislative proposals
- Take positions – may testify at legislative hearings
- Work with legislators on legislation that we would have developed and passed.
- Form coalitions
- Hire a lobbyist to influence legislation to support work of WNA lobbyist
- Develop grass-roots and “Call to Action” campaigns
- Provide education to nurses and nursing students.
- Communicate to the members

## WNA Legislative Priorities for the next Legislative Biennium

- We have three priorities:
  - APRN Modernization Act – Provide separate licensure to practice as an Advanced Practice Registered Nurse (APRN) NP, CNS, CRNA, CNM
  - State funding for scholarships and loan forgiveness for nurses who want to be nurse educators. MSN, DNP, PhD. Monies would be included in the 2021-2023 Wisconsin State Budget.
  - Build our Public Health Infrastructure. Public Health Departments did not have enough staff and resources to adequately address the COVID pandemic. Dollars need to be reinfused to support public health emergencies, prevention and population health.
