Frawley, APNP, BC-ADM, ANP, CDCES - Diabetes Program Coordinator, Sauk Prairie Healthcare	Older adults living with diabetes encounter numerous challenges in self-management on a daily basis due to aging-related changes in hearing, vision, dexterity, mobility, and cognition. Social determinants of health also impact older adult diabetes self-care. Additionally, contemporary diabetes practice often includes technology such as mobile phones, insulin pens and pumps, continuous glucose monitors/sensors, and computers which can (and often do) add another layer of complexity to diabetes self-management for older adults. This session will engage storytelling and participant discussion regarding obstacles faced by older adults who have diabetes and offer suggestions for addressing and mitigating those impediments.	
2B	.50	Physiology of Diabetes: How Eating Disorders Impact Teens with T1DM	Hannah Lochner, RD, LD, CD, CDCES - Registered Dietitian and Diabetes Educator, Aurora Health Care and Rosewood Ranch for Eating Disorders	Will explore the pathophysiology of type 1 diabetes and current trends in treatment and how this puts patients at an increased risk of developing an eating disorder. Will define DSM-5 criteria for eating disorders and how insulin omission and manipulation can be a form of purging. Will go through case studies from outpatient diabetes care with focus on recognizing and screening for “diabulimia” and other eating disorders in teens with type 1 diabetes, and how to support recovery at outpatient level. Will discuss how Rosewood Ranch is set up to support recovery for patients at an inpatient and residential level of treatment with specific case studies. Lastly, will discuss the largely debated question of “can insulin pumps be used with someone who has diabulimia and manipulates insulin?”

Diabetes care and education specialists play an integral role in helping youth with diabetes take charge of their health care when they are moving into adulthood. This session will cover the basics of what health care transition is, resources available to help, and skills that can be developed. We then move into a discussion around empowering young people with diabetes to engage in their own health care and remain healthy as they move to the adult health care system.
